# LIVE AT WARTBURG

Located on 34 scenic acres in Mt. Vernon, NY, the Wartburg campus offers a full spectrum of senior living options – from private townhomes rich with amenities to award-winning nursing home care. Our residents enjoy:



**Independent Senior Living** with a choice of privately leased townhomes or apartments, all with a blanket of security and proximity to healthcare.

**Affordable Senior Living** through our energy-efficient Friedrichs Residence, which features a fitness room, business center, wireless internet and more.

**Assisted Living** options, with services that provide a meaningful life of self-reliance that's both stimulating and comfortable, including a specialized memory care neighborhood for those living with Alzheimer's or dementia.

**Nursing Home Care** voted one of the "Best Nursing Homes in New York" for the ninth consecutive year in 2019 by *U.S. News & World Report*.

**Palliative and Hospice Care** that offers a compassionate grounding force during difficult times. Our team includes medical specialists, counselors, social workers and full-time chaplains.

**Respite Care** that provides safe, warm, attentive care for short stays [from 2 to 30 days], so you or a loved one can rest and recharge.

At the heart of Wartburg's mission is an enduring commitment to serving those with the greatest needs. With 85 percent of nursing home residents at or below the poverty line, the healthcare landscape is dynamically changing, including reductions in government reimbursements for care. Due to underpayments in the state's Medicaid reimbursement program, the average nursing home receives 20 percent less than the actual cost of providing care. Thus, in 2020, Wartburg incurred more than \$7,500,000 in uncompensated care.

## Home Care

Wartburg offers long-term home health care services in Westchester, NY, and licensed, certified home care services in Westchester and the Bronx. Plans may include:

- Assistance with activities of daily living
- Individualized healthcare plans
- Specialized dementia and diabetes care
- Companion services
- Bath and breakfast service as needed

## Adult Day Care

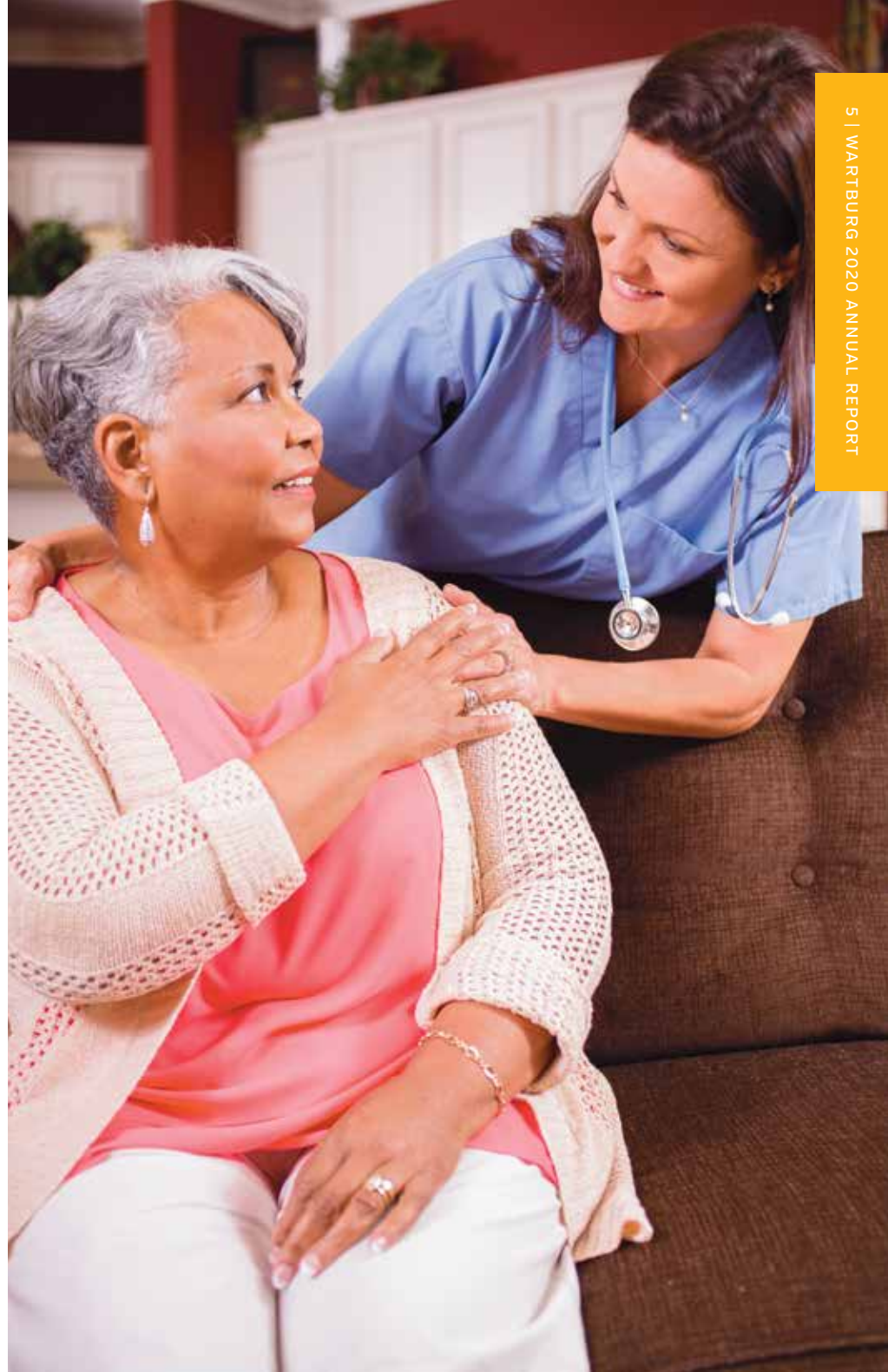
Participants enjoy a safe, inclusive environment with creative and social activities, staffed by specialists trained in Alzheimer's and dementia support. Features include:

- Round-trip transportation
- Council for Creative Aging & Lifelong Learning programs
- Spiritual care for all faiths
- Live entertainment, educational and exercise programs
- Monthly caregiver support group

## Rehabilitation

We are proud to have Westchester's only freestanding rehabilitation center – a state-of-the-art facility with all private rooms and baths. We treat patients who are facing:

- Impaired mobility, balance or coordination
- Limitations in joint strength and motion
- Speech and communication problems
- Changes to memory, reasoning and rational thinking
- Speech and communication difficulties

**What is your position at Wartburg?**

Occupational Therapist [OT]

**Why did you choose to work at Wartburg?**

It was 11 years ago, and I had just completed OT fieldwork in a skilled nursing facility (SNF) in which I gained a new perspective on the aging population. I had just completed my master's degree from Sacred Heart University Graduate School and was finally ready to apply my academic knowledge as an occupational therapist. Since having my last fieldwork assignment at a SNF, I developed a passion to work among the geriatric population. Wartburg became my first job and the start of my career.

**How does your work make an impact on the population Wartburg serves?**

My job as an occupational therapist is extremely rewarding in this population. OTs help patients develop, recover, improve, as well as maintain the skills needed for daily living and working following recovery from an injury.

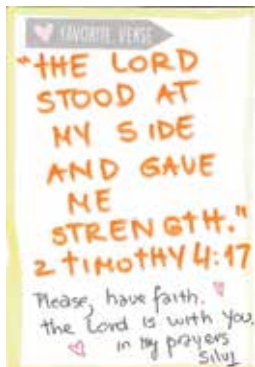

## Memory Care and Campus Expansion

When it comes to memory care, the statistics are staggering:

In response to the rising need, Wartburg is engaged in a multiphase Memory Care expansion on its 34-acre campus.

**PHASE 1** includes expanding Meadowview Assisted Living's common space, such as the dining and lounge areas on the first floor of Wartburg's existing Memory Care neighborhood. The expansion will more than double the resident capacity in our Memory Care wing.

**PHASE 2** includes the construction of an additional Memory Care building on the southwest corner of the campus, providing additional family-style housing in a safe, stimulating environment for those living with Alzheimer's disease or dementia.

Rounding out the plans for Wartburg's campus transformation is a modernization of its Skilled Nursing Facility to include family-style dining, upgraded technology and enhanced patient monitoring.

## CAMPUS EXPANSION, ADDITIONS & MODERNIZATION



### THE NEED:

The current lack of affordable senior housing in Westchester County is alarming. With an exponential increase in the 65-plus population expected over the next two decades, housing insecurity will be among the most critical challenges facing seniors and their families – and will continue to grow.



### THE SOLUTION:

Wartburg offers a range of independent living options in a vibrant, welcoming community. In addition to Lohman Village's 31 step-free townhomes and the 61 supportive senior apartments that make up the Friedrichs Residence, Wartburg is planning an independent living expansion that will offer active seniors 195 well-appointed units boasting over 14,000 square feet of amenity space.

### Uncompensated Care

The Skilled Nursing Facility, Licensed Home Care and Adult Day Care programs accept all patients regardless of their ability to pay or payer source. Many of the seniors we serve live at or below the poverty line and are eligible for Medicaid, which through its established rates reimburses Wartburg for providing the care. However, in many cases this reimbursement is below the actual cost incurred. The cost of uncompensated care is as follows:
